Children's Rights in Germany and Europe: Politics, Science and Practice- International Conference in Berlin

The public event is being organized in cooperation with the Deutsche Gesellschaft e.V./The European Information Centre in Berlin. It will serve ENMCR to become more known in the "Child Rights Scene". Practitioners from the children and youth sector (NGOs, representatives of public institutions) have been invited to voice their needs as to what kind of academic qualification is required for successfully implementing children's rights in practical work.

Effective participation possibilities for children and youth will be discussed in an afternoon expert talk after participation projects have been presented by coordinators. Besides participation possibilities the instrument Child Rights Programming will be introduced by representatives of Save the Children. In an evening panel discussion with politicians, professionals and scientists from Germany and the European Union, a broader public audience should be sensitised for the implementation of the rights of the child. Neuralgic and critical points of the UN convention on the rights of the child will be discussed. The conference will take place on Thursday, 29th September, 2005, from 14-22h in Berlin. Next Internal ENMCR Meeting

We will use the opportunity of being gathered for the conference to hold an internal ENMCR meeting on Friday, September 30th, 2005. As we are expecting possible new members, especially from Central- and East Europe, we will use the time to present work and experiences, get to know each other and discuss possibilities for future cooperation. Evaluation and Quality Assurance mechanisms for teaching and university systems will be another issue for discussion.

Ethnographic Knowledge - an approach to the field of education

The Danish University of Education is offering a course (in English) about Ethnographic Knowledge which will take place from 10^{th} - 13^{th} October, in Copenhagen/Denmark.

The course has got a value of 6 points (ECTS) and is limited for 20 students.

<u>Content</u>: A prerequisite for this course is that ethnographic methods must form at least part of the empirical base of the PhD project, but the course is open to participants in all phases of their PhD studies. The course focuses on methods and methodological discussions central to ethnographic research. An objective of the course is to provide the participants with an understanding of the kind of reflections necessary for the ethnographic approach, and, therefore, lectures combined with participants' presentations of the methodological design of their projects will form the core of the course. The course aims to heighten the student's awareness of methodological issues and ethical considerations when undertaking ethnographic research, such as reflections on ways to participate, the objects of research and different ways of constructing a field. Attention is focused on developing reflexive skills in order to overcome problems and challenges related to research design, field-experiences, and data collection, analysis and interpretation.

Promoting the Creation of Ombudsman for Children [publication]

Through a new report, "Children's Ombudsman Save the Children Norway's experiences with supporting and co-operating with independent institutions protecting children's rights", Save the Children Norway wants to present an overview of these activities in the relevant programme countries. The report draws general conclusions on experiences and lessons learned and proposes action points for further work. The world's first ombudsman for children was appointed in Norway in 1981. According to the latest counts, there are now more than 60 ombudsman for children

offices around the world. Most of them are at national level, others at state or province level. In a generic way they could be referred to as "independent institutions protecting children's rights". This report is aimed at child rights organisations that are interested in or involved in efforts to advocate for the establishment of independent institutions for children's rights.

Juvenile Justice: Rights of Children in the Penal System [conferences]
