

### **International interdisciplinary conference: Rehabilitation and Reintegration of War-Affected Children (RRWAC) Call for papers**

**Date: 22-23 October 2009; Location: Brussels - Belgium**

Two perspectives are central to the conference: the more individual oriented psychosocial support to war-affected children and the more society oriented transitional justice perspective. Children's rights offer the overarching framework. Key questions are how to bridge the gaps between different perspectives (rights, transitional justice, care and aid), and different phases (emergency relief, development aid) regarding the needs of war-affected children. Geographically, the focus will be on the Great Lakes region in Africa and on South America.

This is an excellent opportunity to discuss experiences, challenges and achievements with people and organizations interested in working with war-affected children from different perspectives and in different countries, including service providers, researchers, policy makers, community workers, teachers,...

#### **Call for Papers**

Three time slots have been dedicated to paper presentations. Papers are welcomed on all issues related to the overall theme of the conference. Priority themes are:

- Case-studies, in particular on the Great Lakes Region (Africa) and on South-America
- Appropriate methods of rehabilitation, including culture and tradition based therapy,

ecological approaches

- Interaction and integration of emergency relief and development cooperation, including critical perspectives, operational perspectives, case studies, peace and human rights education

### **Reminder: Call for applications for the European Master in Childhood Studies and Children's Rights at the Freie Universität Berlin**

For the third time, the Freie Universität Berlin is offering the 1 year, 60 ECTS Master study programme which is mainly directed to professionals working with and/or for children and young people and to those who would like to start working in the field. Applications can be submitted until April 30<sup>th</sup>, to commence studying in early October 2009.

In the course, skills and knowledge to work in childhood and children's rights relevant institutions and organisations are imparted by highly qualified teachers. The course has been taken by a variety of students so far, ranging from disciplines such as: Social Workers, Politicians to Lawyers and economists. The EMCR is organised mainly in weekend blocks in order to enable professionals to work alongside studying. However, we recommend not to work more than half time, as the programme is quite intense. The programme is offered mainly in English, yet materials and readings in German are also discussed, therefore a minimum knowledge of German is required.

#### **Eurochild is disappointed about European Summit**

Eurochild is disappointed in the outcome of the European Summit held in Brussels on 19/20 March. The final 'Presidency Conclusions' focus entirely on financial and economic aspects. There is one short paragraph referring to the importance of social security systems, which also states that "particular attention should be given to the most vulnerable and to new risks of exclusion".

Concrete resolutions or other social aspects are missing. The fight against poverty or the role of the social pillar in the post-Lisbon era is not mentioned at all.

### **Next European Forum on the Rights of the Child in June 2009**

The European Forum on the Rights of the Child is a permanent group for the promotion of children's rights, in internal and external action, and should meet in plenary at least twice a year. The role of the Forum is to advise and assist the Commission and other European Institutions, in particular as regards mainstreaming of children's rights, and exchange information and good practice. The Forum aims to be a place allowing for children's opinions to be heard and taken into account.

Members of the Forum are Member States representatives, Ombudspersons for children, representatives of the European Parliament, the European Economic and Social Committee, the Council of Europe, UNICEF and NGOs.

The **next European Forum on the Rights of the Child** is foreseen to take place in **June 2009**.

### **EU Commission plans to crack down on modern slavery and child sexual abuse**

On 25 March, the European Commission adopted two proposals for new rules to step up the fight against trafficking in human beings and child sexual abuse, sexual exploitation and child pornography. These new proposals replace existing legislation which has been in place since respectively 2002 and 2004. The new proposals will guarantee full alignment with the highest European standards, provide better assistance for victims and tougher action against criminals responsible for child sexual abuse and trafficking. The proposals also deal with the rapidly changing technologies in the cyberspace.

### **European Parliament calls for support to children left behind by migrant parents**

The European Parliament adopted on 12 March a resolution which aim is to give support to the children left in their country of origin by parents working abroad. The resolution calls the Commission to undertake a study on the extent of the phenomenon, to involve the social partners and NGOs in actions aiming to improve the situation of migrants' children, and to propose the adequate application of the already existing means to all interested parties. The resolution also calls the Member States to act in order to ensure the normal education and social development of the children.

### **Community programme on protecting children using the Internet and other communication technologies - "Safer Internet"**

The Programme "Safer Internet" has the overall aim to promote safer use of the Internet and other communication technologies, especially by children, promote the development of a safe online environment, reduce the amount of illegal content disseminated online, tackle potentially harmful conduct online (including the psychological manipulation of children with a view to sexual abuse and 'grooming', which is the process by which an adult befriends a child with the intention of committing sexual abuse, electronic harassment and electronic files showing physical and/or psychological aggression) and ensure public awareness of online risks and precautions, as well as to develop pedagogical tools on the basis of sound practices.

To achieve this objective, the Programme will focus on practical help for the end-user, particularly children, parents, carers, teachers and educators, by encouraging multi-stakeholder partnerships. The Programme will be implemented through four general action lines:

1. Ensuring public awareness.
2. Fighting against illegal content and harmful conduct online.
3. Promoting a safer online environment.
4. Establishing a knowledge base.

### **First International Congress of Young Global Leaders for Peace:**

**Date: 14- 15 May, 2009 Location: Castellon, Spain**

organized by the *Fundación Tierra de Hombres* (Delegación Comunitat Valenciana) together with the *Fundación por la Cooperación con Benín* and *Fundación por la Justicia*.

The aim of the conference is to promote, inform and educate youth on the present situation of constant child rights violations everywhere in this world, and possible ways to change this situation. At the same time we intend to put in practice in our congress "the children's right of participation", taken down in the UN-CRC, as teenagers and young adults will have the opportunity to give their opinion and discuss about critical problems like child soldiers, child labour exploitation or child prostitution. It will draw together young practitioners, representatives from NGOs and academics at international level. Twelve young people with deep-rooted positive values, who already act as global leaders, will pass on their vital experience to the 200 participants, and will share how they themselves decided to change this situation of injustice. They will demonstrate how they succeed in their daily work to build a society which has more respect for the rights of children and youth.

After these presentations working groups will be formed to reflect critically on the causes of this serious violation of children's rights and possible ways to restore these violated rights and to raise awareness in society. On the basis of the conclusions drawn during the working group activities we will formulate general recommendations which will be presented to international organisations and several NGOs which develop activities related to this topic.

The main topics of the Conference will be: Stop the Use of Child Soldiers; Child Prostitution; Child Labour Exploitation

There is no conference fee, but there is a limited number of seats. We will offer materials, copies of abstracts and available papers and coffee breaks to all the participants. On Wednesday 11 March 2009, an all-day event called '20 Years of the Convention on the Rights of the Child: Achievements and Challenges for its full Realisation' was held during the 10th session of the Human Rights Council.

CRIN was in Geneva to report on the day.

### **Working Group on the Quality of Childhood: 'Young children and their services: developing a European approach'**

#### **Next session: Tue, 28 April; Location: European Parliament**

The subject: 'Young children and their services: developing a European approach' with Professor Peter Moss of the Thomas Coram Research Unit, Institute of Education, University of London and the Editor of the magazine 'Children in Europe'. The session is hosted by MEP Mrs Rovana Plumb. Professor Peter Moss can be considered as one of the key children advocates in the European Union. From 1988 until 1996 he was in the Employment and Social Affairs Directorate-General within the European Commission the Coordinator of the Childcare Network. This Network produced for use within the European Commission a report entitled 'Quality Targets for Young Children'. This report can still be considered as a landmark publication in this area. Because of certain political developments the Childcare Network was dissolved in 1996, but Peter Moss and the other Network Partners decided to carry on on their own. They succeeded in creating in 2001 an international magazine called Children in Europe in thirteen languages and fifteen countries in Europe. Peter Moss became the editor of this magazine. The countries are: Spain, UK, Italy, Germany, Belgium (French), Belgium / the Netherlands (Dutch), Poland, Denmark, France, Portugal, Sweden, Croatia and Hungary. The 14th issue was also published in Romania. In 2008 the Children in Europe Group published a Manifesto entitled 'Young children and their services: developing a European approach'.

**"Hier geblieben!" (stay here!) theatre play for people from age 12 by Reyna Bruns, Magdalena Grazewicz and Dirk Laucke (in German)**

**Date: 28 May 2009, 11 and 18h; Location: GRIPS MITTE (Podewil) directly at U2-station Klosterstraße**

GRIPS Theater is continuing to play for Refugee Protection and Children's Rights. Shortly before the EU elections, „hier geblieben“ will be shown once again in Berlin. Afterwards the performers and initiators will discuss about the situation of refugees with human rights organisations. The play was written by three young authors who tell the authentic story of the school pupil Tanja Ristic. The girl was taken from her classroom in school to her parents who were in deportation detention. Thanks to the efforts and activities of her classmates her and her mother are allowed to remain in Germany until now. The class was awarded the Mete-Eksi-Prize for their activities and her teachers the Carl-von-Ossietsky-Medal. Tanja's story is exemplary for still more than 140.000 so called "tolerated" refugees in Germany. The play has been performed more than 230 times all over Germany and has attracted attention to the refugees' situation.

### **Everyday fears**

### **A special place for children**

A report was adopted by the European Parliament in February 2009 concerning the needs of children in the EU and the emphasis that must be placed on their basic needs both in internal and external policies. The report contained Action Plans that provide support towards this cause, while it also included alarming statistics concerning the lives and conditions of children throughout the EU.

It is a common belief that children constitute the future and with the well-being of children, the EU will highly benefit in the long-run, since this will be passed on to future generations as well. Significant issues, as child trafficking, violence, education and difficulties in the work environment and employment are addressed.

It is quite distressing that more than 300,000 children are born each year with HIV positive and that 10 million children die each year from diseases that can be prevented. The above figures and facts, and the fact that the voices of these children and even adults are not being heard, has created the need for a framework and for actions that will uplift such phenomena and provide these children with the chance at a better future and the opportunity to live the life they deserve.

The Communication from the Commission to the Council, European Parliament, the European Economic and Social Committee and the Committee of the Regions, strives to establish a common framework for the EU so as to protect and promote the rights of children and ensure that the process can be applied throughout the world, while all actors and involved parties are fully committed to the cause. In order to determine the means and instruments necessary to achieve this, the EU must take into consideration the differing situations and conditions of each country.

This will be accomplished by managing all the instruments that are available so as to take into account the existing difference, as follows: 1. Children and youth in development cooperation. The EU, according to the report, needs to make use of development cooperation and actions to eliminate poverty in those countries

that do not have the instruments to do so.

2. Children and youth in trade policy. Policies developed by the EU should identify the necessity for the protection and the promotion of all human rights.
3. Children and youth in political dialogue. Being that political dialogue plays a significant role in the EU and serves as a means of communication between different institutions, organizations and authorities, importance should be placed on such dialogues so as to implement the Convention on the Rights of the Child.
4. Regional and global actions. Actions that are undertaken at a national level will be accompanied by regional and global actions to address crucial issues.
5. The empowerment of children and youth. The fact that children and youth do not play an active role in everyday society should be concentrated on, by empowering children and youth and allowing them to take a stand in issues that affect them directly and indirectly.
6. Children and youth in humanitarian aid. Humanitarian aid must address those countries that are in conflict or may be recovering from conflict since the needs of children and youth are often surpassed and not met.
7. Separated and unaccompanied children
8. Children associated with armed forces or armed groups
9. Children's education in emergencies.

All of the above must be addressed by the EU so as to ensure that the rights of children throughout are met and focused on. The report has provided with the need to address the above issues, while the EU places great emphasis on actions and initiatives in the above fields.

### **European Union Fundamental Rights Agency: Indicators are an important step towards targeted policies (Report)**

The European Union Fundamental Rights Agency (FRA) presented on 25 March a new report on 'Developing indicators for the protection, respect and promotion of the rights of the child in the European Union'. This proposes a comprehensive series of indicators to measure child rights across the EU. Indicators have been developed by the Agency in the following areas: Family Environment and Alternative Care; Protection from Exploitation and Violence; Education, Citizenship and Cultural Activities; and Adequate Standard of Living. ### **Amici dei Bambini: Life after institutional care project - an overview on the first phase of research**

The first main findings of the on-going research project on young people leaving the care system in Italy, France, Latvia, Bulgaria and Rumania are now out. They reveal just how much work needs to be done to help young people overcome difficulties after leaving care and to promote their complete social inclusion. They show there is a lack of data and information on young people once they left public care. There are few statistics on social services delivered and their impact, resulting in heavy reliance on data available about young people still in care. Moreover, it appears clear that social policies concerning leaving care are poor. Competences in the social protection system are fragmented and there are no clear procedures for specific actions. The policies addressing care-leavers are minimal

and specific initiatives insufficient as well as resources are often insufficient. Finally, there is a lack of quality programmes in care. Understaffing and lack of resources block implementation of legal standards for preparation of young care-leavers. What emerged is the shortage of specific as well as regular training for social care givers and of specific preparation initiatives.

From this first analysis, some clear challenges are underlined: there is a need to develop a holistic approach to the problem and increase monitoring analysis; existing initiatives must be reinforced and new initiatives supported to help young people in their path towards independence; direct participation of young people needs to be increased at all levels.

Initial results were first presented in Eurochild's Annual Conference in November. Project partners met to discuss and develop these results in a second workshop of the European research group in Milan (14-16th January 2009).
