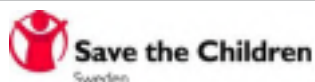
With Rebecca Budde's maternity leave, Katja Schulze joins the coordination team in Berlin. Welcome Katja! We wish you a great start.

International Conference "Safe Childhood in a Global World"

The ENMCR member Mikolas Romeris University with support of the EU Education and Culture Life Long Learning Programme GRUNDTVIG realized the International Conference "Safe Childhood in a Global World" on October 6 in Vilnius, Lithuania

The conference was principally dealing with the topic of cyberbullying. It was opened by the Lithuanian Children's Rights Ombudsperson Edita Žiobienė on the "Lithuanian Experience Ensuring Child's Safety", and by Manfred Liebel from the International Academy at the Free University Berlin under the slogan "Participation is the Best Way to Protect Children".

The conference was closed by Živilė Vilma Jonynienė and Brigita Kairienė from Mikolas Romeris University on the topic "Punishment of a child in a perspective of the CRC". Speakers and participants came from Greece, Italy, Poland, Germany and Lithuania.

2nd International Conference of ICYRNet: Children, Young People and

Adults: Extending the Conversation

The 2nd International Conference of the International Childhood and Youth Research Network titled "Children, Young People and Adults: Extending the Conversation" has been announced. The Conference will be hosted by the University of Central Lancashire between the 5th and 7th of September, 2012.

Linked to the Conference will be an international gathering of children and young people titled "Young Citizens: Different Voices in Global Conversations" focused broadly on citizenship, participation, agency and dialogue. This bringing together of children, young people, and adults will provide a unique and rare opportunity to share ideas and engage in conversation together. Judging from our experience (and as many of you might remember) with the 1st International Conference of the Network in Nicosia, this event will also likely attract a significant number of scholars from all over the globe and provide an opportunity for productive dialogue, networking and collaboration.

First International Student Intensive Program in the Framework of the EU TEMPUS Program Diploma in Public Policy and Child Rights in Egypt and Jordan

Noemi Fivat, EU coordinator of the joint TEMPUS project at Free University Berlin, organized an international student intensive program in Amman in cooperation with the University of Jordan. The 10-day-intensive program on Social Media and Youth Participation which took place between 7-16 September 2011 gathered 18 participants and was facilitated by experts in the area of child rights from the EU and the Middle East. During the workshop, students took part in lectures on topics such as the use, potential and role of social media, communication and empowerment, inequality and

access to the digital world, digital democracy and participation as well as media during crisis and under suppressive circumstances. The participative and interactive sessions were accompanied by web-based exercises including the creation of a new social network named Engage! with discussion forums, blogs, presentations and the creation of a short film. First E-Training in Jordan in the framework of the EU TEMPUS Project

The Free University of Berlin's Center for Digital Systems (CeDiS) organized a 3-day training for the lecturers of the DPPCR at the University of Jordan and at Hashemite University in Jordan. During the workshops, 15 lecturers from both universities were trained in the use of Blackboard for their teaching and had the opportunity to get to know each other, to exchange experiences and to discuss further collaboration both between DPPCR lecturers and students.

Measuring the Scope, Quality and Impact of Children's Participation

The Research Forum for the Child and the Improving Children's Lives (ENMCR Member) is hosting a public seminar on Tuesday 06 December 2011. The theme of the seminar is 'Measuring the Scope, Quality and Impact of Children's Participation'. Gerison Lansdown, International Children's Rights Consultant and Research Forum for the Child Visiting Scholar, will highlight a new initiative designed to explore the impact of children's participation while Paula Keenan, Strategic and Operational Adviser with the Participation Network, and Eamonn Keenan of Playboard NI will highlight examples of local best practice. Committee on the Rights of the Child

Between the 19th of September to the 7th of October 2011 the State members: Iceland, Italy, Panama, Republic of Korea, Seychelles and Syrian Arab Republic submitted their periodic report to the Committee on the Rights of the Child. And for the first time Sweden submitted its initial report to the Optional Protocol to the Convention on the Rights of the Child on the Sale of Children, Child Prostitution and Child Pornography. <http://www2.ohchr.org/english/bodies/crc/crcs58.htm>

Optional Protocol on the sale of children, child prostitution and child pornography

New Zealand and San Marino become the latest countries to ratify the Optional Protocol on the sale of children, child prostitution and child pornography. The state parties to the UN CRC San Marino and New Zealand ratified the Optional Protocol on the sale of children, child prostitution and child pornography. Since May 2010 the Optional Protocol has since been the target of a campaign whose objective is to have world ratification. Since the campaign was launched 12 states have ratified it. First visit to Timor-Leste by UN Special Rapporteur on extreme poverty and human rights

From 13 to 18 November 2011 the UN Special Rapporteur on extreme poverty and human rights, Magdalena Sepúlveda was in Timor Leste to collect information on the situation of

Serbia: Law on the Rights of the Child

Efforts are made in Serbia to adopt a law on the Rights of the Child. With the support of the Human Rights Ombudsman in Serbia, the Working group for the drafting of the Child Rights Act is working on this document for two years and counts independent members and some representatives of the government. The Working group also debated with children, promoting child participation in decisions affecting them. It is expected that by the second half of 2012 the law on the Rights of the Child is adopted.

Kenya: Parliament Debates Cancer Bill

The Kenyan Parliament recently passed a Motion compelling the Government to make cancer treatment free of charge. According to Juliane Kippenberg, senior children's rights researcher at Human Rights Watch "the majority of cancer sufferers in Kenya do not have access to the curative or palliative care they need, and children are at a particular disadvantage". The Human Rights Watch explains on its website that "When children with cancer are found to be in need of strong pain drugs, such as oral morphine, health workers often deny such treatment because they lack training on providing morphine treatment for children, or

they consider the need to use morphine a defeat.". With the new bill it is expected that paediatric cancer and palliative care will improve children's wellbeing.

Voices of children on climate change

Nowadays, questions regarding climate change do not involve child participation; therefore, UNICEF is urging media to consult with children on what they believe to be the key issues surrounding climate change. Due to the fact that the 17th Conference of Parties (COP 17) of the UN Framework Convention on Climate Change will take place in South Africa, UNICEF is preparing to launch in mid-November 2011 a study which highlights the importance of child participation in designing effective responses to climate change.

The study: "The Impact of Climate Change on Children in South Africa" reveals that there are a number of existing initiatives in South Africa through which children are participating in the climate change agenda.

Call for papers and poster presentations:  
"Child in the City"

The European Network of Child Friendly Cities (EN CFC) promotes the rights and interests of children and young people in their local communities, raising social and political awareness around the importance of child development for general socio-economic welfare. For the International Conference "Child in the City" which will take place in Zagreb, Croatia, from 26 to 28 September 2012 call for papers and poster presentations are open.

Child in the City aims at encouraging cities in becoming more child friendly and the four themes for the conference in 2012 are: Health, Play, Children's Rights and Intergenerational.

All applications must include an abstract of the presentation. Only one speaker per presentation is allowed. The abstract must be: clearly written in English (maximum length of the paper should not exceed one A4 Page, letter type Arial 11, Word File) and refer to the criteria: relation with "child friendliness" (this includes 3 basic criteria for all papers and posters - equality in opportunities -; taking care of integral child and participation); relation with the local political level; relation with one of the main themes mentioned previously; non commercial message; relevant for other cities.

Accepted abstracts are scheduled as either posters or presentations. The length of the presentation at the conference will be 20 minutes, including time for answering questions. The conference language is English.

Call for Submission - 4th European Award of Excellence "City for Children"

In the context of increasing international local competition, child-friendly urban planning has become an important location factor. Cities need to attract families by providing child-friendly living spaces. The standard of urban neighbourhoods is especially important for children's quality of life. The 4th European Award of Excellence "City for Children" is therefore directed at projects in the field of "Child-Friendly Neighbourhood Planning".

The Award will be given to projects, in which neighbourhoods are designed with a holistic approach. The jury searches for innovative neighbourhood planning projects which take the perspective of children and their families when conceptualizing the qualities of urban areas with regards to development, architecture, free spaces and usage. Submitted projects should focus on being socially inclusive as well as ecologically and socially sustainable. Subjects to submission must be projects of neighbourhood planning

that either lead to the construction of new neighbourhoods or which remodelled existing neighbourhoods.

The projects must be conceptualized according to the needs of children and young people in the context of integrated, interdisciplinary strategies of urban planning.

The selection criteria includes: Neighbourhood Planning; Innovation; Expected yield; Acceptance by users; Degree of participation; Transferability to other municipalities; Publicity strategies; Sustainability. The submitted project must already have been implemented in your municipality.

Who is invited to participate?

European cities with more than 100.000 inhabitants also in cooperation with organisations, associations, institutions, companies, churches and other partners who are involved in running or organizing the projects on the ground.

In the case that projects are deemed to be of equal merit, several awards may be conferred.

### Application Requirements

Every city may apply with one flagship project. The application form must be filled in completely and submitted by post to the Cities for Children Coordination Office together with: two A1 sized posters (upright format) displaying the quarter in a 1:500 or 1:1000 map scale and the urban context in a 1:10.000 or 1:20.000 scale; two A3 downsizing of the posters; The plans are to be submitted as print material as well as electronic data (CD, USB, DVD etc.); 20 high resolution pictures of the project, stored on CD, USB or other electronic device, giving a comprehensive and lively impression

of the project; completed application form, sent via e-mail and regular mail.

In Parallel, the application form is to be sent via e-mail. Illustrative material such as photos, DVDs and plans should be sent by post only. Applications must be submitted in English.

Call for abstracts: "Children, Violence, Community and the Physical Environment"

Children, Youth and Environment is the world's leading publication for the latest news on children, youth and their environments, the Journal is a one-stop online resource, which supports the sharing of knowledge across disciplinary and national boundaries.

For the 2012 fall issue, the call for abstracts on the topic Children, Violence, Community and the Physical Environment are open. The aim is to explore the influence of the community and physical environment / place on violence against children. Violence and abuse of children have received much attention from researchers and policymakers in recent times. However, the physical environment in which violence occurs is not often a focus. The 2012 fall issue shall examine the interplay between the communities in which children live, the physical parameters of these environments and the nature and incidence of violence experienced by children and young people - that is, the socio-ecological factors which moderate or aggravate violence

against children. The primary aim shall be to examine the physical environment in which community relations occur and the effect these have on violence against children / youth, or the creation of places of refuge and healing.

All papers should concern themselves with aspects of place. They should make clear how children enact their lives in particular places and how specific place-related characteristics affect their safety.

Abstracts should mention how the ideas in the full paper will apply directly to research or practice. Abstracts for research papers, reviews and field reports may be submitted. Abstracts that offer a comparative or international perspective are particularly welcome.

A new report on Children's Vulnerabilities to Climate Change and Disaster Impacts in East Asia and the Pacific has been recently published. The report presents an analysis of the climate change trends and potential impacts on children in East Asia and the Pacific, drawing on findings from five UNICEF-commissioned country studies in Indonesia, Kiribati, Mongolia, the Philippines and Vanuatu, as well as children's own perspectives on climate change and other research.

Violence against Children

A new report on violence against children reveals that despite numerous commitments and promises by states, millions of children continue to be humiliated, beaten, burned, sexually abused – and even killed – by the adults in their lives, their parents, teachers, caregivers and employers. Marta Santos Pais, mandated by the UN Secretary-General to tackle violence against children, stated the report, "highlights how far we are from safeguarding the right of all children to develop to their full potential in a violence-free environment, as violence remains widespread, socially condoned, and in many cases considered as a lawful practice, form of discipline, or sentencing of children." The report, Five Years On: a global update on violence against children comes five years after a United Nations study documented the magnitude of violence perpetrated against children. It surveyed over 100 separate studies conducted by academic researchers, non-governmental organizations and UN agencies since 2006.

This research project is a youth led research and involves more than 1,512 young people in England. In this report the focus is made on the experiences of and attitudes towards cyber bullying, with a particular focus on age comparisons between older and younger youth.

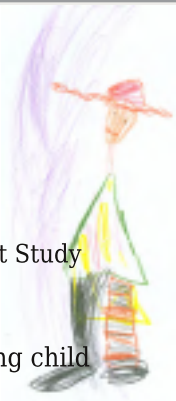
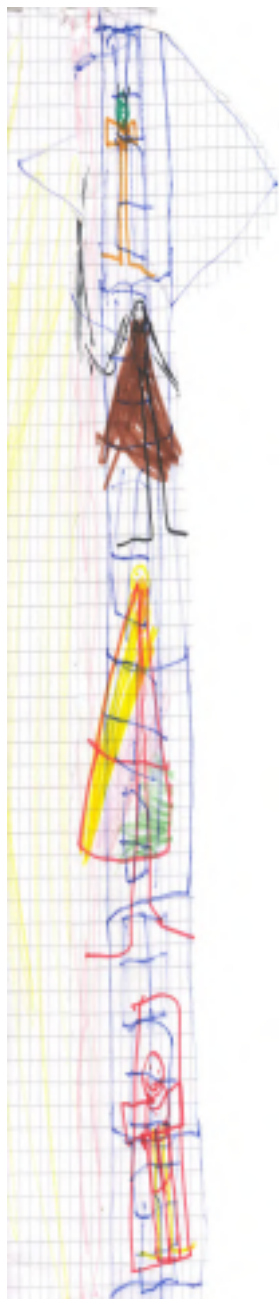
Handbook on Child Participation in Parliament

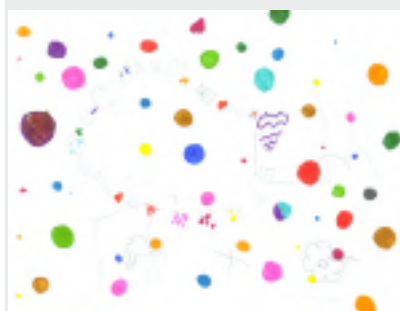

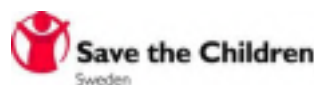
