General Assembly ENMCR 2012

The next General Assembly will be held in Barcelona, Spain on January 12-13, 2012.

The European Network of Masters in Children's Rights brings together universities, institutions and academics dealing with Children's Rights. Its main objective is to organize and implement Master courses and conduct research in Children's Rights.

At the General Assembly children's rights courses at the member institutions will be evaluated, the future organization of the network will be discussed, and a workshop on research of children's subjective wellbeing will be held.

Fellowships and other opportunities at University of Edinburgh (EMCR member)

The University of Edinburgh (EMCR member) intends to appoint up to 100 Chancellor's Fellowships across the University's 22 Schools as an investment in the future of teaching and research.

These prestigious awards are aimed at early career individuals of the highest potential who have begun to establish a reputation for the highest quality research at the forefront of their discipline and who have a commitment to learning and teaching at university level.

The Fellowship may be held in any discipline or interdisciplinary area that fits within the strategic aims of the University and the hosting School. It is essential that the successful candidate's research furthers the high international reputation of the School and the University and that she or he has a strong commitment to postgraduate and undergraduate training.

The Fellowship is held for 5 years, subject to satisfactory review at the end of year 3, and the Fellow will then move to a standard University academic open-ended contract. Candidates already holding an externally-funded Fellowship are welcome to transfer this to Edinburgh if the sponsor permits.

International candidates are welcome and will be supported through the process of visa application if required. Applicants wishing to work in interdisciplinary fields are particularly welcome and in such cases the hosting School will be identified by discussion with the School(s) and the candidate. There are opportunities for Childhood Studies within the Fellowships. The opportunity is excellent for those with an interest in children's rights/international development, which would fit in several of the priority areas in the School of Social & Political Science (Justice and human rights; international development; social policy).

Launch of new Diploma in Public Policy and Child Rights in Egypt and Iordan

After a year and a half of joint curriculum development with the support of European universities and UNICEF, the Diploma in Public Policy and Child Rights has been launched this fall semester at Cairo and Asyut University in Egypt and at the University of Jordan and Hashemite University in Jordan.

In total, around 100 students have been enrolled in this unique program offered for the first time in the MENA (Middle East and North African) region.

This Diploma has been established in response to the need for relevant and appropriate child-friendly legislation, policies, budgets and programs that are based on scientific evidence.

It aims to build a cadre of practitioners working with and for children that effectively use their skills and knowledge to influence adequately funded child rights oriented policies and practices. The Diploma is a one year full time study program consisting of eight courses. Human/children's rights and their core principles determine the overarching approach for the design of this Diploma.

Ethiopia National Plan to prevent new HIV infections amongst children

On December 4th, 2011 the National Accelerated Plan for Scaling up Prevention of Mother to Child Transmission (PMTCT) in Ethiopia was launched.

Ethiopia is one of 22 sub-Saharan African countries that succeeded in reducing their national rate of new HIV infections by 25% between 2001 and 2009.

According to government estimates, approximately 1.2 million people were living with HIV in Ethiopia in 2010, including about 90 000 pregnant women.

Despite progress in the national HIV response, only 9.3% of pregnant women who are eligible for HIV services are currently receiving them. The overall aim of the plan is to ensure that all pregnant women living with HIV have access to HIV prevention and treatment services, and that new HIV infections among children are eliminated by 2015.

Terre des hommes campaign on environmental children's rights

"terre des hommes Germany has recently launched a campaign with a view to promoting environmental children's rights.

Children around the world face the dire consequences of persistent and wide-spread forms of environmental destruction- many of which also threaten their future (climate change, loss of diversity).

Despite the relevance and urgency of the matter, neither human rights nor environmental politics have developed adequate means to safeguard the rights of children against environmental harm. terre des hommes' campaign aims at raising awareness of the links between environmental and child rights protection and advocates for stronger legal and institutional safeguards.

One of terre des hommes major proposals in this context is the creation of ombudspersons for future generations, a demand which is now shared by many other civil society organisations and states.

So far, terre des hommes has published three comprehensive brochures on child rights threats arising from the use of dangerous and toxic pesticides, extractive industries, and climate change.

Early next year, terre des hommes will also issue a conceptual paper that traces the normative roots of environmental child rights protection, explores the links between child rights and the rights of future generations, and offers ways to strengthen environmental child rights at different levels.

In June 2012, a terre des hommes delegation- including youth representatives from Asia, Latin America, Africa and Europe- will travel to Rio de Janeiro to participate in the UN Conference on Sustainable Development and lobby for a stronger role of children and children's rights in environmental and sustainability politics."

Working children present bill of rights to improve their working conditions

In Bolivia, children and adolescents have drafted a bill that aims a t guaranteeing working children rights and protecting them from discrimination and exploitation. While the International Labour Organization (ILO) has been trying to prohibit child labour worldwide for decades, the authors of the bill

demand recognition of their work and an improvement of their working conditions.

Aside from the legal and social recognition of working children, the drafted bill contains the provision that the right to education should be realized for all working children. It also disappproves a minimum age of working.

Instead, the bill aims for a legal approach to treating working children and adolescents equally as working adults and grants them the same protection.

Public authorities are requested to prevent and protect children from especially hard tasks and prostitution.

New action plan to end child soldiers in Somalia

The United Nations envoy for children and armed conflict secured a commitment from top officials in Somalia's transitional government to start a process to end the recruitment and use of children in the country's armed forces.

The Special Representative of the Secretary-General for Children and Armed Conflict, Radhika Coomaraswamy urged all UN partners to work closely with the Transitional Federal Government (TFG), African Union peacekeeping mission in Somalia (AMISOM), and donors to step up efforts to prevent the recruitment of children, and to release and reintegrate of those formerly associated with armed forces and groups.

The UN supports programmes for the reintegration of children associated with armed forces and groups. Such programmes promote rehabilitation of children through counselling, back-to-school initiatives and skills-based training, including family reunification.

Saturday 7th July 2012 - Monday 9th July 2012. Mansfield College, Oxford, United Kingdom

This inter and multi-disciplinary conference project seeks to investigate and explore all aspects of childhood. The period of life prior to adulthood is one of dramatic change and development of physical, intellectual, psychological, and many other types of characteristics.

The nature of childhood and its significance as a separate phase of life, however, is viewed quite differently in different cultures and in different historical eras.

This conference will look at all aspects of the experience of childhood as well as the social and cultural perceptions of children and childhood.

We encourage submissions on any theme to do with the nature of childhood, including, but not limited to the ones listed below.

- 1. Definitions of Childhood
- 2. Childhood and Development
- 3. Children and Relationships

Please use plain text (Times Roman 12) and abstain from using footnotes and any special formatting, characters or emphasis (such as bold, italics or underline).

Please note that a Book of Abstracts is planned for the end of the year.
All accepted abstracts will be included in this publication.

We acknowledge receipt and answer to all paper proposals submitted. If you do not receive a reply from us in a week you should assume we did not receive your proposal; We suggest, then, to look for an alternative electronic route or resend.

<u>Call for submissions on child's right</u> to health

The CRC Committee welcomes inputs on the child's right to health, in English, French or Spanish, particularly from interested organizations and individuals who have extensive experience or information on the right to health of children under eighteen.

The submissions are invited to address the following questions:
(1) What should be the basic premises for the realization of children's right

to health?

- (2) How can the principles of the CRC, in particular articles 2, 3, 6 and 12, be applied to designing, implementing and monitoring interventions to address child and adolescent health challenges and what aspects are specific to a child's rights approach to health?
- (3) What is the normative content of article 24? What are the specific obligations of States under article 24? What are the responsibilities of non-state actors under article 24?
- (4) What are the priority concerns in general and in particular regions of the world for the implementation of article 24?
- (5) Which concrete measures should be put in place to implement article 24?

The submissions shall not address the content of Article 24.3, which will be covered by a separate joint General Comment/Recommendation currently being produced by the CRC Committee in collaboration with the Committee on the Elimination of All Forms of Discrimination against Women (CEDAW).

The submissions should be limited to 5 pages and sent to the following email address in Word format no later than 6 January 2012: crc@ohchr.org. All submissions should be accompanied by a brief presentation (1 paragraph is sufficient) on the experience of the submitting individual or organization on the subject matter.

The submissions received will subsequently be posted on a webpage dedicated to the General Comment. Please note that the United Nations does not offer remuneration of any kind for inputs into General Comments.

<u>Call for abstracts: Sociology of</u> <u>Childhood - Theorising Childhood</u>

The Research Network, Sociology of Children and Childhood hereby announces the mid-term symposium which will take place in Jyväskylä (Finland) on June 18- 20, 2012. The organisation of the symposium will be undertaken at the University of Jyväskylä.

The focus of the symposium will be on theorising childhood.

There are a growing number of empirical sociological and interdisciplinary studies of children in a wide variety of contexts where children live their lives.

This has moved from school-based studies to those of children's everyday lives in their homes, playgrounds, online.

The overarching approach of the social studies of childhood has been to perceive the actions of children in terms of children's own competences and this has led to a number of ground breaking insights into the worlds of children and their viewpoints and perspectives on matters that were traditionally deemed `beyond children's understanding'.

However, with a few very notable exceptions, theorising these aspects has not followed to the extent of other sociological fields.

Although the focus of the symposium is around theorising childhood, the papers for the sessions do not have to deal with the overall theme. It is open to all core areas of the sociology of childhood.

We invite experienced and young researchers from various disciplines sensitive to the sociology of childhood to participate.

Although a particular focus to presentations and discussions will centre on theorising, participants are welcome to discuss also their implications for interdisciplinary work on childhood.

Presentations can be related to the following areas:

- 1. "Sociological classics" (Marx, Durkheim, Weber) do they still matter?
- 2. Other classical theories of childhood and generation, such as Mannheim
- 3. New directions in sociological theory, such as network theories, normalisation processes, or the approaches of thinkers, such as Bourdieu, Foucault, Luhmann, Bauman, amongst others
- 4. The concept of spatiality in theorising childhood
- 5. How are rights, inequalities and injustices in childhood theorised?
- 6. How are theorisations around gender and ethnicity applied to children?
- 7. What is the role of theory in interdisciplinary work?
- 8. What are the questions of cultural identity and citizenship for children?

Please note there will be a conference fee to cover services (lunch, drinks, etc.).

The number of delegates will also be restricted to 30 to enable discussion. The papers will be selected according to relevance to the theme of the symposium.

The abstracts must be written in English, maximum of 400 words, and must include 3-5 keywords. Please submit your abstract and complete contact details no later than February 28, 2012 to Tom Cockburn (t.d.cockburn@bradford.ac.uk). Notification of abstracts will be March 31, 2012.

The Brazilian Federal Senate for Human Rights has recently published Brazil: Civil society proposals to address violence against children it was written by Cristiano Morsolin, operator of international networks for the rights of children in Latin America and co-founder of the Observatory Selvas

The author writes, "Social violence - in its various manifestations as armed conflict, crime, violence, institutional and gender, maltreatment of children and adolescents - is one of the biggest problems existing in Latin America. Children and adolescents are one of the most affected by both direct and indirect manifestations of violence ".

<u>Children's social and emotional</u> <u>wellbeing in schools</u>

The new book co- authored by Debbie Watson, Carl Emery, Phillip Bayliss with Margaret Boushel and Karen McInnes challenges the uncritical acceptance of the concept of wellbeing as it is applied to children, particularly in a school-based context.

Taking a post-structural approach, it suggests that wellbeing should be understood, and experiences revealed, at the level of the subjective child, rather than children's wellbeing being reduced to an objective list of things that are needed to live well.

The book explores social and emotional wellbeing (SEWB) for children and explores three key propositions: that SEWB is subjectively experienced, situated and contextual and located in children's relationships with others.

The authors deconstruct the concept of wellbeing in order to see it differently and the chapters explore key themes including: revisiting the status of the child, challenging Cartesian dualist ideas of wellbeing, accessing minority voices on wellbeing, not pathologising difference and Othering and new understandings of professionals and professionalism. The book concludes with how SEWB with, and for, children could be differently approached in respect of policy and practice and the implications for theorising child wellbeing.

This issue explores how the impacts of economic crises are transmitted to

children's experiences of poverty and well-being, and how these impacts can be mediated by the policy responses of international and national actors. In this publication the lessons which can be derived from responses to past crises and the extent to which these lessons are being applied are also considered.

World report on disability

Studies have shown that people with disabilities have generally poorer health, lower education achievements, fewer economic opportunities and higher rates of poverty than people without disabilities.

This is largely due to the lack of services available to them and the many obstacles they face in their everyday lives.

The report provides the best available evidence about what works to overcome barriers to health care, rehabilitation, education, employment, and support services, and to create the environments which will enable people with disabilities to flourish.

The report ends with a concrete set of recommended actions for governments and their partners.

Special attention is given to children with disabilities in chapter 2 (disability - a global picture), 3 (general health care),4 (rehabilitation) and 7 (education).
