The Gender Dimension of the Worst Forms of Child Labour (public meeting and round table discussion)

Date: 25 June, 9am-1pm; Location: ParkHotel, The Hague

Organisers: IREWOC, ILO/IPEC, UCW and IISG. A decade has passed since the ILO adopted Convention 182, in which the worst forms are given priority in the struggle against child labour.

Generally, boys are more involved than girls in child labour and hazardous work. Nonetheless, female children run greater risks, are more likely than boys not to be attending school, and the 'invisible' nature of female children make them extremely vulnerable to various forms of exploitation. The public meeting will be held with discussants from The Netherlands, Brazil, India, Ethiopia, Kenya, among others, and with speakers from the ILO, UCW, IREWOC, Plan International etc.

Presentations and speeches will focus on the relevance of C182, stage of implementation, and progress made. The second part of the morning session will be a round table discussion, chaired by Professor Jaap Doek, on the progress and challenges in the fight against (girl) child labour. Roma Conference: Removing Barriers and Fostering Inclusion for Roma Children

Date: 2-3 June; Location: Belgrade, Serbia

The overall goal of the conference is to review the results achieved in the improvement in education of Roma during 5 years of the decade for Roma inclusion and to further elaborate the road map for ensuring the fulfilment of the universal right to quality education for Roma children.

The conference will examine the importance of incl. children early in education; monitoring and ending segregation and sustaining integration; ensuring access and coverage in regular schooling;

classroom and school environment supportive to education quality and changes in financing education system to enable inclusion. Conference: Easier said than done: 20 years of children's rights between law and practice

Date: 11-12 June; Location: London

Within the field of human rights in general, emphasis has been placed on the legal dimension and the incorporation of intl. conventions into domestic legislation. The CRC and its near global ratification have been seen as true accomplishments in this sense. Yet, despite this recognition and success, the range and severity of problems faced by children at the start of the twenty-first century are persisting, if not increasing. The year 2009 marks the 20th anniversary of the CRC. The occasion provides a timely opportunity to assess the value of the CRC in engaging with dilemmas on the ground, in devising multi-faceted approaches other than a purely legal or technical response, and in evolving to meet new challenges that emerge from its practical implementation.

A new era of EU policies for youth - Commission adopts a new EU strategy for youth

The European Commission adopted the new EU strategy for youth policy for the coming decade on 27 April 2009 entitled "Youth - Investing and Empowering". The new strategy acknowledges that young people are one of the most vulnerable groups in society, especially in the current economic and financial crisis, and in our ageing society, young people are a precious resource. The new strategy is cross-sectoral, with both short- and long-term actions. The actions involve key policy areas that affect Europe's young people, particularly youth education, employment, creativity and entrepreneurship, social inclusion, health and sport, civic participation, and volunteering.

The new strategy also emphasises the importance of youth work and defines reinforced measures for a

better implementation of youth policies at the EU level.

The strategy "Youth: Investing and Empowering", which is a follow-up to the renewed social agenda announced by the European Commission in 2008, has the following goals: to create more opportunities for youth in education and employment; to improve access and full participation of all young people in society; and to foster solidarity between youth and society.

"A new form of prostitution"- new show on German private TV channel: Being adult on trial
Dschungelcamp for babys? Children's Protectionist want to sue RTL, as the new show „being an adult on trial“ lends young children to teenagers. An example: little Ricardo is screaming and boxing- the camera focusses on him. The boy throws himself to the ground in a tantrum and cries- the cameras takes a close view of his face. The mother cannot cope with the situation, she grabs her son hard and starts screaming herself. The little sister starts crying as well. Cut: the pedagogue Katharina Saalfrank (super nanny) looks understanding and asks: "is it like this with you all the time?" This is one of thousands of scenes of these super nanny formats, where children are exposed to stressful situation in front of cameras- you can see them every day if you zap through the programmes- not only in Germany, but even more so in the USA, UK, Netherlands. Even though many have threatened to launch a lawsuit, RTL has plans to stick to the new show, which is to start on June 3rd. With the record viewing numbers reached in other states with this new show, RTL can easily finance any charges, if charges would at all follow the law suit.

have been launched, which choose and provide funding to projects that aim towards the establishment of a more secure and protected internet environment for users, and especially young individuals, which also constitute the largest group of users of the internet and technologies in general. The Safer Internet Programme also materializes events each year, incl. the Safer Internet Day (each year in February in order to promote safer and more responsible use of online technology) and the Safer Internet Forum. Further, Safer Internet Centres have been set up and are working in more than 25 countries in the EU. These centres have hotlines which individuals can call so as to get advice or help on how to access the internet in the most secure and responsible way. The hotlines can be also used to report any misuse or illegal content and to raise awareness in general on the uses of the internet and other such aspects relating to internet technology. The Safer Internet Programme is open to a wide range of organizations and institutions and allows for the cooperation between stakeholders in order to make the Internet more secure. Funding is most often provided to NGOs that deal with the well-being of children online, to different law enforcement bodies that deal with the exploitation of the internet and to researchers that conduct research on the use of the internet, risks and other such issues.

France. Report: The ethics of the security forces when minors are present (early May)

Juvenile delinquency is currently object of criminal policies which are becoming more and more repressive according to the research carried out by the National French Commission on the Ethics of Security. The report highlights the importance of the security forces considering minors who are offenders or not, as a vulnerable being because their involvement in a police intervention may have serious repercussions on their development.

In spite of the existence of texts on the protection of minors, according to this study it still often occurs that young people still suffer moral or physical damage in confrontations with security forces. This report is aimed at professionals attending to minors and always uses as a reference the minor's best interest.

Child Poverty Action Group (UK) has published on 21 April a briefing drawn from a new league table of child wellbeing in European countries. This briefing draws on the results of a new league table of child wellbeing in 29 European countries produced by researchers from the University of York. It includes 43 separate indicators, summarised in seven domains of child wellbeing. The Netherlands comes top of the table, followed by Norway and Sweden.

Legal instruments for combating racism on the Internet (21/ 04/ 2009)

Various national and international legal instruments punish hate speech. However, the specific nature of the Internet calls for the adoption of new strategies to combat hate speech promoting racism and violence, which is widely and swiftly disseminated on the web. As the Internet ignores territories and has no boundaries, states cannot control it effectively by unilateral national regulation: so what is needed is increased international co-operation. Efforts to harmonise national legislation - including the Additional Protocol to the Council of Europe Convention on Cybercrime - have come up against a series of difficulties. One of these is the fact that there is no universally accepted definition of the illegal nature of racist speech, which can be protected by the right to freedom of expression. This book describes the situation in ten Council of Europe member and observer, states and discusses the problems faced and solutions introduced by these countries and by European and international organisations and civil society. Council of Europe - Activity report 2008 (23/ 04/ 2009)

The year 2008 was very busy and eventful for the Council of Europe with, among other things, Kosovo's unilateral declaration of independence in February and the conflict that erupted during the summer between Georgia and Russia, two of the Organisation's member states. It also saw the adoption of the "White Paper on Intercultural Dialogue" and the gradual incorporation of its principles into the Organisation's activities. The public information campaign "Speak out against Discrimination" was launched in partnership with the media. There were also campaigns focusing on the death penalty, violence against women, Roma and children's rights. Another significant development was the entry into force of the Council of Europe Convention on Action against Trafficking in Human Beings. These are among the points dealt with in this report, which also covers the entire range of work carried out by the Organisation's different bodies in all its sectors of activity. European Convention on the Adoption of Children (revised) and explanatory report, 27.XI.2008, CETS No. 202 (16/ 03/ 2009)

The aim of the European Convention on the Adoption of Children (revised) (CETS No. 202) is to set out a collection of legal rules aimed at harmonising the adoption of children in Europe according to the core principles of the Council of Europe. The convention takes account of the social and legal developments of recent years as well as the case law of the European Court of Human Rights. It underlines that the best interests of the child must always take precedence over any other considerations. To place an order directly

Call for proposals for the pilot project "Child Abduction Alert"

The EU has launched a new call in its Fundamental Rights and Citizenship programme open to: National law enforcement/judicial authorities; Non-governmental organisations with an agreement with the above national authorities to handle cases of child abductions; Public or private entities with an agreement with the above national authorities to disseminate the alerts. **Proposals from ALL other applicants will be REJECTED automatically.**

The deadline for submission of applications is **17 June 2009 24:00 CET**.

The specific objectives of the project are:

- a) To set up child alert mechanisms in the Member States,
- b) To increase the compatibility and coordination of child alert schemes between the Member States,
