First Luso Brazilian Symposium in Childhood Studies: Sociological and Educational Perspectives

Over the past two decades Childhood Studies gained a growing scientific visibility.

Researchers studying the generational group of children have focused a great part of their work to research with children.

In order to consolidate this practice, research has been developed in the childhood studies field.

The cooperation between Portuguese and Brazilian researchers has reinforced this consolidation.

However, both in Brazil and Portugal there are different positions seeking to build discourses in different scientific areas and there are different theoretical and methodological approaches contributing to the characterization of the life of children. In order to promote the dialogue in the Childhood Studies field, researchers from Brazil and Portugal are invited to present their work at the *First Luso- Brazilian Symposium on Childhood Studies: Sociological and Educational Perspectives*.

This event will be held on June 4 and 5, 2012, in Braga, Portugal at the Institute of Education, University of Minho.

Children rights, wellbeing and protection

The Conference *Children rights, wellbeing and protection* was held in April 27 to 29 at the Babes-Bolyai University, Cluj-Napoca, Romania (ENMCR Members).

At the Conference researchers from Romania, alongside with international experts, public services and NGO social workers have gathered to demonstrate the existence of a rich knowledge base in the field of Romanian Children's Rights, Welfare and Protection.

Firstly, researchers focused on the Welfare of Children (their quality of life, right to education, freedom of speech and to benefit from prevention and recovery services). A very interesting research reported about invisible children, meaning that their needs, struggles and sufferings are unknown to the authorities.

Another much discussed issue was about objective and subjective approaches in researches related to children welfare and their quality of life.

Presented topics also focused on the experiences of children with parents working abroad; others pointed out the important changes made in the child protection system and that continuous improvements are needed in order to respond to children needs and assure that protection also improves child welfare and children's participation in social life.

Recommendations are that listening to children is one of the resources to responding to their needs.

Related to the right to education, researchers highlighted the existent educational barriers and that in order to include disadvantaged children in education, parents and teachers need to be listened to.

Secondly, researchers focused on Protecting Children from Any Form of Violence, and discussed child maltreatment assessment and the system of monitoring child abuse and neglect.

Researchers concluded that there is a need to review and look into those cases of malpractices in order to improve procedures and policies.

The conclusions of BECAN research highlighted that in Romania, the traditional parenting methods contribute to a large number of children suffering from violence in their homes, still unknown to professionals.

Other papers focused on children witnessing domestic violence and the importance to address their needs. Finally, recommendations were made in order to improve the Romanian system of monitoring child abuse and neglect, such as: developing child maltreatment definitions that allow comparing data from different domains, developing tools that address the professionals needs to identify abuse and also improving the methods for monitoring the risk factors regarding violence and its short-term and long-term consequences.

The conference debates highlighted the need to improve existent services, develop new services and to review and renew the existent legislation and procedures.

Postdoctoral Fellowship in Childhood Studies

At the Norwegian Centre for Child Research (NOSEB) (ENMCR Member) there is a vacant postdoctoral fellow in the area of Childhood Studies for a period of three (3) years, whereof one (1) year is with work obligations to the centre. The aim of the postdoctoral fellow is to provide funding to an excellent candidate who has recently defended an approved PhD-thesis or has an equivalent degree in a social science. Applicants with a PhD in social anthropology, sociology or geography or a background in social studies of children and childhood will be preferred.

A major part of the centre's research activities is within an area that crosses over the fields of childhood, society and children's everyday lives in diverse social, cultural and economic conditions. The proposed postdoctoral project should therefore be related to one or more of the following themes:

- Childhood, Culture and Society
- Media and Consumption
- Rights, Health and Welfare
- Day Care, School and Leisure
- Poverty

In the proposal of no more than 7 pages the following shall be identified: the research theme, questions to be illuminated, theoretical foundation, methods, progress and publication plans, and references.

In evaluating the proposal and application, the project's quality, its relevance for society and the applicant's motivation to contribute to the on-going formation of a dynamic and competitive research institution, will be heavily emphasized. Personal traits such as creativity, problem-solving, being a good listener as well as discussant, a team-builder as well as capable of working independently, will be preferred.

Together with the application, the following should be attached:

- Project proposal, including motivation and a plan for the research
- Curriculum Vitae, certified copies of school certificates and diplomas
- Documentation of relevant work

We work within a broad area of discourse analysis, such as Membership Category Analysis, Conversation Analysis, Biopolitics, Narrative Analysis, Genealogy, Archaeology, Discursive Psychology, Governmentality, Deconstructionism, Discourse Theory, Performativity, Rhetoric, and Material-Semiotics.

The hands-on conference is an opportunity to present and collectively analyse empirical material, in one of the following three workshops:

- 1) Poststructuralism and Foucault,
- 2) Narrative Analysis
- 3) Conversation Analysis and Discursive Psychology.

The conference will be held at the Department of Child and Youth Studies, Stockholm University (ENMCR Member). Conference languages are English and Swedish. The workshop is free of charge but you are required to finance your meals and accommodation.

5th Psychosocial Studies Network Conference Knowing and Not Knowing

The conference *Knowing and Not Knowing: Thinking psychosocially about learning and resistance to learning* will take place at the Institute of Education (ENMCR Member) on December, 17 and 18, 2012. The conference will generate discussions which explore and develop psychosocial conceptualisations of

knowing and not knowing, learning and resistance: the flows and blockages positioned within individuals and institutions, and within the discursive and material processes that constitute these social identities. At the conference one aim is to encompass the various and contrasting ways these ideas are interpreted in psychosocial approaches to research and practice. Another aim is to create an innovative space for productive discussion and exploration of these ideas. In a move away from conventional conference formats that is consistent with an attempt to put into question traditional formations of knowledge, we are inviting submissions for 3 different types of contribution:

- 5 minute presentation + 25 minute discussion of a work in progress
- 90 minute panel/workshop
- 90 minute video /performance /exhibition + discussion

We welcome submissions from interested academics, researchers, research students and practitioners working in any relevant disciplinary or professional field, for example: anthropology, cultural studies, economics, education, gender studies, history, legal studies, management, media studies, medical studies, politics, post colonial studies, psychology, psychoanalysis, psychotherapy, social policy, social work and sociology.

Presentation and discussion:

Draft papers/discussion papers/works in progress of 1500- 3000 words are invited for the morning sessions of the conference. Within the sessions each presenter will be allocated thirty minutes, with a maximum of 5 minutes for presentation and the rest of the time for discussion. Accepted pieces will be grouped by theme for the morning sessions and circulated prior to the conference. There will be an expectation that attendees at each session will have read the papers for that session in advance.

Egypt: New child marriage laws

An Egyptian MP has confirmed the drafting of a new law to lower the permitted age for girls to marry to just 14 from the current age 18.

Egypt's National Council of Women (NCW) has already appealed to parliament to stop the legislation, saying it rids women of their basic educational and employment rights. Early marriage is considered a violation of human rights and it is a harmful traditional practice and is a form of sexual violence against children, particularly young girls.

Philippines: Lowering Minimum Age Of Criminal Responsibility

In the Philippines the House Bill 6052 intends to reduce the minimum age of criminal responsibility.

This legislative proposal to reduce the minimum age of criminal responsibility is not unanimous amongst different political and legislative actors.

Based on patterns and studies in different countries, lowering the minimum age of criminal responsibility does not necessarily result in a decrease in the crime rates and incidents of juvenile offending, especially because the Philippines has been a pioneering country in juvenile justice reforms.

The House Bill 6052 proposed amendments to lower the minimum age of criminal responsibility from 15-years-old to 12-years-old.

Adolescents and youth

The United Nations Commission on Population and Development adopted a resolution that provides a major boost to the sexual and reproductive health and reproductive rights of adolescents and youth.

The resolution urges governments to:

- Promote equal opportunities for all and combat all forms of discrimination against young people, particularly against girls and young women.
- Provide comprehensive education to young people on human sexuality, sexual and reproductive health, human rights and gender equality;
- Deliver comprehensive sexual and

reproductive health services based on privacy, confidentiality and non-discrimination, and improve maternal health, reduce maternal and child morbidity and death, and prevent and respond to HIV and AIDS;

- Protect the rights of adolescents and youth to decide freely and responsibly about their sexuality, including their sexual and reproductive health;

Belgium: Child Poverty

In Belgium, 510,000 minors live in households at risk of poverty or social exclusion, according to a report on the effects of the crisis published by Unicef.

With 23.2% of children at risk of poverty, Belgium is below the European average (27.1%), but above the French (23%), Luxembourg (22.3%), German (21.7%) and Dutch (16.9%).

The risk of poverty is highest in Romania (48.7%) while the lowest in Finland (14.2%).

Portugal: Children affected by austerity measures

Human Rights Education Associates reports that fiscal austerity measures have disproportionately affected the human rights of the most vulnerable social groups, especially children. More than 20% of the children and the elderly have been considered to be at risk of poverty and an increasing number of children in Portugal drop out of school in order to find employment and support their families and themselves.



Council of Europe: four-year plan for children's rights

The Council of Europe adopted a strategy to protect and promote children's rights.

The strategy is a response to the needs expressed by governments, professionals working with children, civil society and children themselves who ask for more efforts to be made in implementing existing standards. In order to achieve this, the Council of Europe will provide guidance and support to its 47 member states on how best to bridge gaps between the rights and the reality of children in Europe.

The strategy will focus on four main objectives:

- promoting child-friendly services and systems (in the areas of justice, health and social services);
- eliminating all forms of violence against children (including sexual violence, trafficking, corporal punishment and violence in schools);
- guaranteeing the rights of children in vulnerable situations (such as those with disabilities, in detention, in alternative care, migrant or Roma children)
- promoting child participation.

Child participation in justice proceedings

The Fundamental Rights Agency of the European Union (FRA) is working on a qualitative research project on child participation in justice proceedings.

The involvement of children in justice procedures is an important topic for European Institutions and for Member States. International and European standards advocate for active participation of children, however the legislation and practices at national level differ widely.

The aim of the research is to identify practices and procedures of child participation in criminal (as victims or witnesses) and civil justice proceedings in a selection of European Member States, and to assess how the Council of Europe Guidelines on child-friendly justice are applied.

The research output will serve to inform policy makers and further advise Member States on good practices.

Call for papers: International PhD Mentoring-Workshop on Children's Well-Being

The International Society for Child Indicators Research (ISCI) in collaboration with the European Science Foundation (ESF) is organizing an international mentoring workshop for PhD students. This PhD workshop offers the opportunity for doctoral students to discuss their PhD projects with international experts in the fields of qualitative and quantitative research on children's well-being. After giving a 20 minutes presentation the participants will get feedback from well-known members of the ISCI scientific board and will get the opportunity to debate with them and with other PhD students from Europe.

The presentations of the PhD projects can be about:

- General questions about research design
- Research methods for research with children
- Analysis of data collection
- Theoretical debates about children's well-being

As this is a mentoring workshop, problems and questions about work in progress can be discussed within the presentations.

A limited number of grants are available to cover accommodation and travel (200-400€).

For application, we request an abstract of 500 words maximum (including the research design you are using or planning to use in your PhD project and the question you want to focus on in your presentation).

After a selection, a number of applicants will be invited to submit a full paper by 1 September 2012.

Selected papers by the participants will be published in the Child Indicators Research Journal.

Call for proposals: Strategic Impact Evaluation Fund

The Strategic Impact Evaluation

Fund (SIEF) is a new trust fund established within the World Bank to carry out and support research evaluating the impact of programs on alleviating poverty and improving people's lives. The knowledge generated will provide evidence for designing more effective policies and programs. The SIEF aims to improve the effectiveness of development policies by expanding the evidence base on the impact of scalable programs affecting human development outcomes. This first call for proposals will focus on four thematic research clusters chosen for their strategic policy relevance:

- Early childhood nutrition, health and development;
- Water supply, sanitation, and hygiene linked to human development outcomes;
- Basic education service delivery;
- Health systems and service delivery

Call for papers: Poverty and Politics in Middle Income Countries

This Workshop organized by CROP and the Institute for Social Development, University of the Western Cape, aims to enhance comparative and critical views of poverty politics; to consolidate the recently formed Working Group on Poverty Politics and Social Policy, and to prepare the publication of an anthology based on selected contributions.

The workshop will bring together participants from across all university disciplines, addressing one or several of the following questions:

- Is poverty reduction in MICs distinctive?
- Social development: reduced extreme poverty, increased inequality?
- Public policies and politics: less

important than economics?

- Politically vulnerable welfare regimes?

The workshop will bring together a maximum of 20 participants from across all university disciplines. This call for papers is open to all, although preference will be given to researchers based in Africa, Asia, Latin America and the Caribbean. A limited number of travel grants will be assigned according to geographic origin and the relevance, quality, and originality of the submitted abstracts. In the case of co-authored papers, only one author may compete for a travel grant.

The seminar will be conducted in English.

The abstract should not exceed 500 words (one page) and must include: the title of the proposed paper and a summary of its theme, including its central argument and research question. In addition, a brief resume (max. one page) clearly indicating your name, title, nationality, and contact information as well as a list of recent publications.

Born too soon: the global action report on preterm birth

Born too soon: the global action report on preterm birth provides the first-ever national, regional and global estimates of preterm birth.

The report shows the extent to which preterm birth is on the rise in most countries, and is now the second leading cause of death globally for children under five, after pneumonia. Addressing preterm birth is an urgent priority for reaching Millennium Development Goal 4, which calls for the reduction of child deaths by two-thirds by 2015.

This report shows that rapid change is possible and identifies priority actions for everyone. Born Too Soon proposes actions for policy, programs and research by all partners – from governments to NGOs to the business community - that if acted upon, will substantially reduce the toll of preterm birth, especially in high-burden countries.

This report is a joint effort of almost 50 international, regional and national organizations, led by the March of Dimes, The Partnership for Maternal, Newborn & Child Health, Save the Children and the World Health Organization in support of the Every Woman Every Child effort, led by UN Secretary-General Ban Ki-moon. 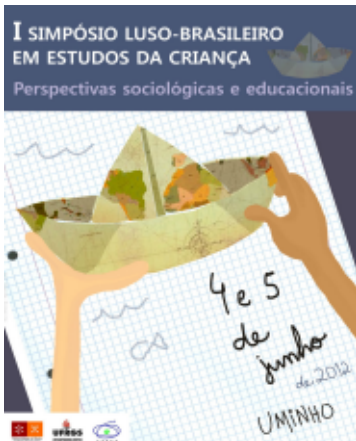
Children and the Capability Approach

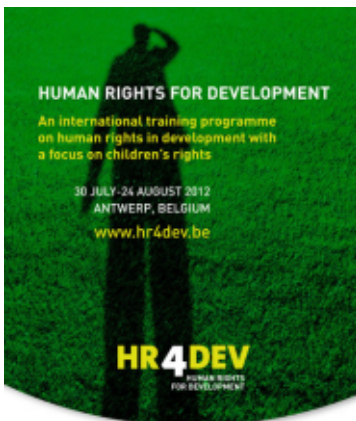
