### International Symposium: JANUSZ KORCZAK- Children Rights Pioneer

Janusz Korczak (1878 - 1942), the Polish-Jewish pediatric, writer and educator, was a children's rights pioneer.

He not only verbalized and claimed children's rights but also lived and practiced them.

His work remains a challenge to the theory and practice of children's rights in an emancipatory sense. 100 years ago he founded in Warsaw the first orphanage; 70 years ago he was murdered with 200 Jewish children and his collaborators in the Nazi extinction camp Treblinka. In the context of the International Korczak Year, proclaimed by the Polish parliament, the EMCR at the Free University Berlin celebrates an international symposium on October 13, 2012.

Through the symposium the importance of Korczak for the recognition and development of children's rights, this is until today underestimated, will be appreciated. Korczak's educational practice and his theoretical writings, novels and children's books will be analysed by experts from Poland and Germany. The symposium was prepared by a

For the 6th consecutive year the Free University Berlin will start a new cycle of the EMCR.

The program was offered in previous years at FU Berlin and it proved to be a positive experience for many.

This year students from India, Iran, Wales, Germany, England, Bulgaria, the Netherlands, Peru and Paraguay will join the program. Of almost 90 applicants over 20 have been successful.

This year students have different backgrounds and work experience such as Medicine, Law, Social Work, Psychology, Psychotherapy. Many of this year students completed volunteer service and worked as volunteers with disadvantaged children.

### International summer course Human Rights for Development

From 30 July to 24 August 2012, the first edition of the international summer course Human Rights for Development (HR4DEV) took place. HR4DEV builds on the successful international interdisciplinary course Children's Rights in a Globalized World (2008 and 2010).

The summer course mapped the potential and limits of human rights in development and development cooperation, with a specific focus on children's rights. Divided into two parts (a general part – two weeks on human rights and development; and a thematic part – two weeks on children's rights and globalisation), the main themes covered included a

contextualisation of human rights in the development debate, paradigms of human rights and development, critical approaches to children's rights in theory and practice, and global challenges to children's rights. The course targeted 'leaders of the future' in practice, policy and academia.

Through lectures, workshops, individual papers, group work and excursions, the programme aimed at promoting knowledge, insight and skills in the field of human rights and children's rights, and at developing young leaders in policy, practice and academia. The course was designed to enable participants to pass on this knowledge and skills in their own context (according to the train-the-trainers model), on the one hand, and to stimulate critical and strategic reflection on the integration of human rights and children's rights in their professional activities, on the other hand.

A total of 56 professionals from NGOs, national human rights organisations, the government, international organisations, academics and doctoral students, as well as grass root workers and policy makers, participated in the course. HR4DEV is a joint initiative of two Flemish interuniversity partnerships: the Flemish Interuniversity Research Network on Law and Development (LAW&DEV) and the Children's Rights Knowledge Centre (KeKi), in cooperation with the Institute of Development Policy and Management (University of Antwerp). Wouter Vandenhoe, holder of the UNICEF Chair in Children's Rights at the University of Antwerp, a member of ENMCR, was the local organizer. ### Argentina: Proposed law to lower voting age to 16

Argentina is rethinking what it means to be a citizen, proposing radical changes that would have both foreigners and 16-year-olds vote to determine who should run the country. President Cristina Fernandez's legislative powerbrokers say the proposed electoral laws will enhance democracy and challenge the world to treat voting as a universal human right. With approval likely in a Congress controlled by the president's allies, the laws would expand Argentina's electorate by three million voters, or roughly ten per cent, and make it among the world's most permissive countries in terms of voting rights. Very few nations [allow] people still in their adolescence to help choose their nation's leaders. Austria, Brazil, Cuba and Nicaragua also start voting at age 16.

### Child soldiers in Myanmar

Two ethnic groups in Myanmar recently became the first rebel fighters to sign a "deed commitment" with Swiss-based rights group Geneva Call, pledging to eliminate underage soldiers and protect children in armed conflict. As signatories the Karenni National Progressive Party/Karenni Army (KNPP/KA) and the New Mon State Party/Mon National Liberation Army (NMSP/MNLA) must ensure that children aged under 18 are not recruited into or used by their armed forces. They are also required to meet obligations related to the well-being and rights of children affected by armed conflict, such as education and assistance for children in areas under their control. ### Chile: students as protesters

139 protesters were arrested as occupiers were evicted from three different schools. At all three establishments, students refused to voluntarily leave the school premises and had to be dispersed with tear gas and pressurised water hoses early. This latest outpouring of dissent comes after talks between student leaders and Santiago Mayor Pablo Zalaquett failed to bring about an agreement, as students rejected Zalaquett's proposals. The use of riot police to evict school occupations has been highly controversial in Chile. More controversial still is the Public Order Control Law, or "Hinzpeter Law" named after Interior Minister Rodrigo Hinzpeter, which proposes increased punishment for unauthorised protests and occupations. Under the law, the occupation of public property is seen as a crime and could carry a three year jail term.

### Italy: Unaccompanied minors

The European Commission is looking into allegations Italy is abusing the rights of asylum seekers by sending unaccompanied minors back to Greece. According to a joint-report by the Greek Refugee Council and the German-based Pro Asyl, Italy is returning undocumented migrants and asylum seekers to Greece without any proper checks.

### Cyprus: Compasito

A manual on human rights education for children is now on offer to primary school teachers who may incorporate it in the following academic year's curriculum, following an initiative from the Hope for Children Foundation and the NGO support centre. Compasito is published in the context of the Council of Europe's youth programme on human rights education. In Cyprus, the manual was translated to Greek with the support of child commissioner Leda Koursoumba and the education ministry.

Call for submissions ahead of day of general discussion: Migrant Children

The Committee on the Rights of the Child is calling for submissions ahead of the Day of General Discussion, which this year takes place on 28 September.

The theme for this year's discussion is "Children in the Context of International Migration"

The purpose of the Days of General Discussion is to foster a deeper understanding of the contents and implications of the Convention as they relate to specific articles or topics.

Representatives of Governments, United Nations human rights mechanisms, United Nations bodies and specialized agencies, non-governmental organizations, national human rights institutions as well as individual experts and children are welcome to take part.

The overall objective of the 2012 DGD is to promote, at the international and national levels, the rights of all children in the context of international migration.

Specific objectives of the 2012 DGD

- Help identify specific child rights issues in the normative, policy and programme areas in relation to all children in international migration situations, regardless of their status (regular or irregular).

- Identify principles and examples of good policies and practices in relation to children in international migration situations.

- Address international standards protecting the rights of the child in the context of international migration and identify how these international standards take or should take into account the guiding principles in the Convention on the Rights of the Child (non-discrimination, best interests of the child, respect for the views of the child and the right to life, survival and development).

- Provide further substantive information for facilitating the Committee's dialogue with and recommendations to States parties on issues relating to the rights of children in international migration situations.

- Raise awareness and promote exchange of information and collaboration among actors/stakeholders dealing with the rights of children in the context of international migration.
