ENMCR General Assembly

Seventeen members of the ENMCR network were present at the ENMCR General Assembly which took place on December 5th, 2013 at the Freie Universität Berlin in Berlin, Germany. During the ENMCR General Assembly the following core issues were presented and discussed:

- Report of activities 2012
- Alumni Network
- Membership applications
- Project start of CREAN and strategic repercussions for the ENMCR

This year the ENMCR has been awarded with EU funding for the CREAN Project, has received a grant from the European Parliament for scientific field research and has an expert participating at the Eurochild expert group on participatory methods for inclusion of children who are vulnerable and/or marginalized. The ENMCR General Assembly was followed by the CREAN Kick- Off meeting in Berlin.

The next General Assembly will be held in September 2013 in Spain.

<u>CREAN: Children's Rights Erasmus</u> Academic Network Kick-Off Meeting

The first meeting with the Children's Rights Erasmus Academic Network (CREAN) partners took place on December 6th and 7th, 2012 in Berlin at the Freie Universität Berlin. The Children's Rights Erasmus Academic Network (CREAN) is a network built onto the existing European Network of Masters in Children's Rights (ENMCR). Through the involvement of 37 project partners with a high academic background from European and non-European countries, CREAN brings a broad range of multidisciplinary into children's rights.

The major aim of the project includes further enhancement of the academic field of children's rights studies as an interdisciplinary field of studies.

The CREAN Kick-Off Meeting focused on the following central topics:

- Key objectives and components of the project;
- Election of the steering committee

- Substantial elaboration on the different work packages of the project;
- Development of the regional networks (Mediterranean and Nordic network);
- Dissemination
 Over the next 34 months this project funded with support from the European Commission will put together:
- Two conferences with different key subjects in the area of children's rights
- Develop interdisciplinary teaching materials through expert workshops
- Create a highly visible body of early career researchers, inter alia by awarding a prize to such researchers
- Exchange teachers across higher education institutions

Save the Children Sweden European Partners Meeting

The ENMCR was present at the Save the Children's Sweden European partners meeting between 12 and 14 of November 2012. In this meeting topics such as Children's Rights and Business, De-institutionalization of children, Bullying Prevention at school and Child Rights and Advocacy were presented and discussed.

The ENMCR also had the opportunity to present the network and its current projects (Tempus and CREAN). In this meeting the ENMCR met partners from the CREDMOS project and partners from the CREAN project, which has recently started with support from the European Commission.

This meeting was important to reinforce the linkage between the network and SCS and to improve its cooperation.

The organization Child Rights Information Centre in Moldova (CRIC) focused on the topic Children Left Behind in its presentation at the partners meeting. CRIC focus its work on the situation of children being left behind when their parents migrate in search of work to sustain their families. Institut Universitaire Kurt Bösch (IUKB): Call for applications

The Master of Advanced Studies in

Children's Rights (MCR) is a parttime two-year postgraduate programme in children's rights, which is jointly organised by the Institut Universitaire Kurt Bösch (ENMCR Member), associated with the International Institute on children's rights (IDE), both in Sion (Switzerland) and the Law School and the Institute for family research and counseling at the University of Fribourg (Switzerland). The MCR is an interdisciplinary and international programme which attracts a diverse range of graduate students from all over the world. The programme is designed for professionals who work with children's rights issues, these may include; lawyers, psychologists, sociologists, judges, social workers, government officials, staff from nongovernmental organisations, academics and journalists. It takes place over a two-year period and requires participants to attend seven compulsory week-long modules over the two years (4 modules during the first year and 3 during the second year). In addition to these residential modules and the completion of exercises and examinations based on the required course reading materials, students are also expected to devise an individual training programme which consists of two obligatory assignments: the submission of a report on conferences or meetings attended and the completion of a research paper (Master's thesis), and

EU Children of Peace initiative

The European Union's Nobel Peace prize money will fund four projects under the EU Children of Peace initiative and details of the projects were announced today by Jose Manuel Barroso, the President of the European Commission. Together the projects will benefit from €2 million (which includes additional EU funding).

They will reach out to over 23,000 conflict-affected children worldwide and will provide access to basic education and child-friendly spaces:

- Around 4,000 Syrian refugee children in camps at the border between Iraq and Syria;
- More than 5,000 Colombian children, most of them refugees in Ecuador:
- 11,000 Congolese children displaced in Eastern Democratic Republic of Congo and refugees in Ethiopia;
- And 3,000 Pakistani children in the conflicted-affected north of the country.

UNICEF will implement the project in Pakistan, Save the Children and the Norwegian Refugee Council will work with children in the Democratic Republic of the Congo and Ethiopia, UNHCR will deliver assistance in Colombia and Ecuador, and ACTED from France is going to work in the Domiz Refugee camp in Northern Iraq with Syrian children.

All these organisations are among the best renowned humanitarian partners of the European Commission.

The projects to be supported through the Children for Peace Initiative fall in the scope of responsibility of the EU Commissioner for Humanitarian Aid and Crisis Response, Kristalina Georgieva.

The EU Children of Peace Initiative will not be a one-off action: new funding will be made available next year for more projects in support of children in conflict.

International Migrants Day

The United Nations' (UN)
International Migrants Day is annually held on December 18 to recognize the efforts, contributions and rights of

migrants worldwide. Child migration occurs all over the world and each region has its own particular patterns and context. Thousands of children are affected.

Mobility can be empowering when it enables access to education, training, income, skills, networks and increased status but it can also carry huge risks, such as exploitation, abuse, lack of family support, problems with authorities, accidents and illness.

Girls and women make up a large portion of the migrant population and are particularly vulnerable to sexual violence and exploitation during the entire migration process.

Addressing child migration requires appropriate means of protection and support for children at all stages of the process – even before they start moving.

However, prevention and response efforts are challenged by a lack of systematic data collection.

This is especially the case with illegal and undocumented migration, which is common and includes significant numbers of unaccompanied children crossing borders.

<u>Ukraine: Action plan to improve</u> children's rights

Ukrainian President Viktor Yanukovych announced an action plan to develop child-focused policy and to boost children's rights protection. Decent and affordable healthcare plays a key role in the country's overall strategy for the protection of children,

Yanukovych said, adding that the state will provide funding for treatment of kids and young people with cancer and other serious illnesses.

Yanukovych expressed concern about the high level of juvenile crime in Ukraine, saying that the authorities have found options to reduce it.

Global Alliance against Child Sexual Abuse Online

On 5 December, 2012, the EU Commissioner for Home Affairs together with US Attorney General Eric Holder launched a Global Alliance against Child Sexual Abuse Online. The initiative aimed to unite decision-makers all around the world to better identify and assist victims and to prosecute the perpetrators. Participants at the launch included Ministers and high-level officials from 27 EU Member States, who were also joined by 21 countries outside the EU. The countries of the alliance were committing themselves to a number of policy targets and goals.

<u>Civil aspects of international child</u> abduction

The European Parliament approved a resolution calling on the Council of the EU to adopt the decision on the declaration of acceptance of eight countries (namely, Gabon, Andorra, the Seychelles, the Russian Federation, Albania, Singapore, Morocco and Armenia) joining the 1980 Hague Convention on the Civil Aspects of International Child Abduction.

The European Parliament urges the Council to proceed immediately with the procedure for the adoption of the proposed decisions. The Hague Convention on the Civil Aspects of International Child Abduction, adopted 25 October 1980, establishes a system allowing participating states to cooperate in order to find a solution to international child abductions, by determining which courts are competent and which law is applicable when deciding where the child should reside.

New members elected: Committee on the Rights of the Child

On December 18, 2012 States met in New York to elect nine members to serve on the United Nations Committee on the Rights of the Child. The successful candidates will replace those whose term will expire on 28 February 2013. The nine candidates elected to the

CRC are from: Austria, Bahrain, Brazil, Ecuador, Ethiopia, Italy, Malaysia, Russia, and Slovakia.

<u>Calls for Abstracts: Protecting</u> children in a changing world

Thirteenth European Regional Conference on Child Abuse. Abstract submission system is now open. Topics to be addressed include:

- Prevention of child abuse and neglect through early and sustained involvement
- Interventions and programmes for children and families experiencing adversity
- Addressing children's rights and participation
- Reforms in child protection and welfare policy
- Children in out-of-home care
- Building an evidence base
- · Contemporary issue

All abstracts will be peer reviewed by the Conference Scientific Committee. The official conference language is English. However, abstracts can also be submitted in French or Spanish. Presentation Formats:

Interactive Poster

A display area will be provided. It is expected that the author will be present at the poster location during the specified presentation time(s) to discuss the contents with the conference participants.

•Free Paper (Oral)
The time allocated for oral presentations is 20 minutes (15 minutes for the presentation and 5 minutes for discussion and questions). Free papers will be grouped together in a chaired session.

Workshop

The length of a workshop is 90 minutes. A workshop is a session involving interactive learning and the dissemination of training and/or skills. Abstracts intended for workshops should indicate how interactive learning will be incorporated into the presentation.

•Symposium

A symposium is a session lasting 90 minutes that includes four or five papers that address a common theme. Each symposium has a named chair/convener, who is responsible for identifying the contributors to the symposium, ensuring they submit abstracts and that they attend the conference. The chair/convener may

also contribute a paper to the symposium. The chair/convener is required to provide an overview abstract for the symposium but individual contributors submit their own abstracts, which should have been agreed with the chair/convener beforehand. Individual authors are required to indicate clearly on their abstract the title of the symposium, in addition to the title of the individual paper. The Conference Scientific Committee will communicate with the symposium chair/convener, who is responsible for communication with the other contributors.

Abstracts should not exceed 300 words. All submissions should be in Times New Roman font size 12 and should include objectives, method, results and conclusions.

Abstract Submission Deadline: January, 18th, 2013.

The conference organising committee invites submissions of high-quality research papers addressing these and other questions relating to child well-being and development in developing countries. Submissions using the Young Lives data are encouraged, although consideration will also be given to papers using other developing country panel data-sets that address related issues. Potential topics of interest include:

What is the extent of inequalities in key indicators of children's human capital and well-being over the child's life-course across, gender, socio-economic status, ethnic group, rural-urban residence, and other dimensions?

How do inequalities evolve and change over the child's life-course? What are the factors that mitigate/reinforce early inequalities and explain the evolution of inequalities over time? If you would like to submit a paper (full papers only; abstracts only will

The British Early Childhood Education Research Association (BECERA) is a new initiative established in 2010 as an independent organisation focusing on research and current practice in early childhood throughout Britain. The BECERA conference is celebrating its 3rd anniversary. The general feeling from the last two conferences was one of community and excitement.

BECERA envisages providing a space for early years practitioners and researchers to come together and share their findings and knowledge. BECERA aims to stimulate, support, create and disseminate rigorous, grounded and conceptual knowledge and its applications to our early childhood services.

This year's theme is Researching Children's Lives: Questions of Practice & Methods' and delegates are invited to submit an individual paper presentation or poster presentation. Papers will be clustered in two (sometimes three) and it will be allocated a time slot for presentation. Chronic Poverty Amid Growth: Insights from Long-Term Poverty **Trajectories**

There has been growing interest in researching the dynamics of poverty, including poverty mobility. Looking at change over time and what caused this change can provide useful information for policymakers and those who seek to influence them. Young Lives makes use of the three rounds of survey data and of qualitative data from sub-sample children. The focus in this paper is tribal households not conforming to the general trend of upward mobility. It locates these households, analyses their characteristics, and identifies the factors that cause the downward mobility of certain households. Available online:

Mobile Technology in Emergencies

The explosive growth in access to mobile phones across the developing world provides a unique opportunity for the humanitarian sector. But the full potential of mobile phones to work as transformative tools in emergency response has not yet been realised.

Mobile Technology in Emergencies draws on interviews with emergency response staff in six countries to identify three key themes that should be addressed in order to change this situation: increasing accountability, building preparedness and prioritising collaboration.

In addition, the report looks in more

detail at mobile cash transfers, which have been a leading context for the use of mobiles in emergencies and have important lessons for the wider use of mobile technology.

The report makes a series of recommendations - to international non-governmental organisations, mobile network operators and governments.

Ending legalised violence against children: Prohibiting and eliminating corporal punishment in all alternative care and day care settings

Ending legalised violence against children: Global report 2012 - the seventh report following up the UN Study on Violence against Children reviews the progress and delays in prohibiting corporal punishment of children throughout the world, with examples of regional and national developments. It shows how prohibiting corporal punishment is not only a child rights issue but is closely linked with the rights of women, the rights of persons with disabilities, and the right to health.

Measuring Household Welfare: Short versus long consumption modules

The literature review mainly focuses on studies from the 1990s on developing countries. Available evidence seems to indicate that short modules underestimate consumption with respect to longer ones resulting in lower levels of recorded consumption and therefore less accurate estimates and higher poverty rates.

Committing to Child Survival: A Promise Renewed – Progress Report 2012 examines trends in child mortality since 1990, analyses the causes of preventable child death. and outlines strategies to accelerate progress. Child deaths fell from nearly 12 million in 1990 to an estimated 6.9 million in 2011, with reductions in all regions.
