IoE: Feminism and the Politics of Childhood: Friends or foes? Workshop at the UCL Institute of Education, London, 16-17th November 2015

#### Call for papers

This workshop will bring together community- and university-based academics and activists to unpack perceived conflicts between children's interests and women's interests (which themselves are heterogeneous) and, more broadly, intersections and antagonisms between various forms of feminism and the politics of childhood.

The lives of women and children are deeply entangled and the way relations between them are conceptualised has implications for approaches to service provision, public education, and social movement building about critical issues including childcare, domestic work and global care chains, familial violence, and the division of labour. Children, to varying degrees, are positioned as primarily dependent and in need of care, and women take by far the greatest responsibility for this, whether in families, education, formal care settings, global care chains, and so on. Women and children have often been elided or linked ideologically. Both feminist and childhood scholars and activists have worked against this conflation, but, in so doing, have been criticised for portraying women and children's interests as opposing and adversarial (Thorne, 1987). Feminist scholars have argued that prioritising children's rights has led to increases in women's ascribed responsibilities for children's wellbeing (Molyneux, 2006; Newberry, 2014) and that rising

attention to 'the child' in the policy arena has side-lined women's citizenship demands (Dobrowolsky Jenson, 2004). Childhood theorists have commented that feminism is an 'adultist' enterprise, rendering children largely absent from the social world and sociological consideration except as objects of social reproduction (Mayall, 2002). Concerns have been raised that this antagonism reduces the complexity of adult-child relations - which include joy, love, reciprocal concern, and solidarity - solely to that of work and burden (Riley, 1987).

Until now, there has been limited attention to the ways these perceived antipathies might be addressed (but see Alanen, 1994; Burman, 2008; Oakley, 1994; Thorne, 1987). We propose to use this workshop as a means to initiate such a dialogue. We are inviting abstracts which address the following, or other relevant, themes:

- \* How do we ensure the well-being of children and women, particularly in contexts where their interests may (appear to) be in conflict?
- \* How might a conversation between feminism and the politics of childhood reconcile these tensions?
- \* Are women's and children's interests necessarily opposed or inevitably linked?
- \* What are the consequences of denaturalizing motherhood and childhood for women and children?
- \* How do we conceptualise women and children's involvement in creating a gendered and generationed social order?
- What are the implications of theorising women and children together?

- \* Does discussing women and children together reify their relationship?
- Where do men, the state, and society fit?
- \* To what extent does this reinforce compulsory heterosexuality?

To promote in-depth discussion and debate, workshop spaces will be limited to a small number of presenters and participants. Working papers of no more than 4000 words will be pre-circulated. At the workshop, each presenter will give a short synopsis which will be followed by discussion. We anticipate producing an edited volume from the workshop. All participants (including presenters) will be charged a nominal fee of £20..

## University of Tartu: seminars on societal psychology

In autumn term 2015/2016, visiting professor Wolfgang Wagner from University of Linz (Austria) is teaching at the Institute of Social Studies.

Professor Wagner is an internationally renowned social psychologist whose numerous publications focus on social and cultural changes, public perception of science, social identities and stereotypes, etc.

He will teach two courses: a lecture course "Social and societal psychology" which is appropriate for students of all levels and specialties, and a seminar course "Social Representation Theory: Implications and Applications" for master and doctoral students.

The courses will take place in English. Registration is already open.

The course will provide an introduction to different approaches in social psychology. In order to develop a feeling for the ways in which culture and society shape how people think, behave and relate to other, the lectures approaches that study how societies "think", how groups and communities develop a sense of identity and prejudice against others and how they represent controversial and politically topical issues affecting local and global public spheres.

#### Malta: Gender equality in schools

State schools in Malta should not particular uniforms impose or facilities on gender variant students, according to a new government policy on gender equality in schools. The new 'Trans, Gender Variant and Intersex Students in Schools Policy' instructs schools to allow pupils to wear uniforms, use facilities and take part in activities that match their gender identity. This includes having a choice of which uniform to wear, which bathroom or changing room to use, and which sports activities and physical education classes to take part in. The policy also says students are to be addressed by their preferred name and pronoun once an application for gender transition has been filed in court. The new policy has been developed over the past year after a number of students had experienced difficulties in education settings and had trouble finding employment as a result of their gender identity. The

policy is the first of its kind in Europe, as no other country has a comprehensive education policy focusing on the needs of trans, gender variant and intersex children.

#### Italy: right to non-discrimination

A court in Italy has ruled that statesanctioned "nomadic camps" are a of form segregation and discrimination based on ethnic grounds, marking the first time in Europe that a national court has reached this decision. The ruling came in response to a 2012 complaint by a group of organisations against the City of Rome for its construction of a Roma-only "village".

#### **UN: independent panel**

UN Secretary-General Ban Ki-moon has appointed an independent panel to investigate the UN's response to allegations of sexual abuse of children by peacekeeping troops in the Central African Republic. The UN came under fire for appearing to be more concerned with finding out how the allegations were made public than ensuring access to justice and support for the victims. A group of civil society organisations, including CRIN, called on the UN Secretary-¬General to clarify measures the UN had taken in response to the reports of sexual abuse. A UN spokesperson said the panel independent will have unrestricted access to all UN records and full access to UN personnel wishing to provide information -seemingly a response to concerns raised by Ian Richards, head of staff union at the UN, on possible repercussions against UN staff for passing on information. The panel will begin work in July, and aim to submit a report within ten weeks, complete with recommendations on how the UN should respond to similar allegations in the future.

### Call for Papers: CfP: Children and War: Past and Present

Third international multidisciplinary conference to be held at the University of Salzburg, Austria, on 13-15 July 2016

Organized by the University of Salzburg and the University of Wolverhampton, in association with the UN Office of the Special Representative of the Secretary-General for Children and Armed Conflict.

This conference is planned as a follow-up to the two successful conferences, which took place at the University of Salzburg in 2010 and 2013. It will continue to build on areas previously investigated, and also open up new fields of academic enquiry.

All research proposals which focus on a topic and theme related to 'Children and War' are welcome, ranging from the experience of war, flight, displacement and resettlement, to relief, rehabilitation and reintegration work, gender issues, persecution, trafficking, sexual violence, trauma and amnesia, the trans-generational impact of persecution, individual and collective memory, educational issues, films and documentaries, artistic and literary approaches, remembrance and memorials, and questions of theory and methodology. Specific conference themes anticipated are:

- Children as victims, witnesses and participants in armed conflicts.
- Holocaust, genocide and forced labour.
- Deportation and displacement, refugees and asylum seekers.
- War crimes, trials and human rights.
- Reflexions on research in politically and culturally diverse contexts.
- Sources produced by NGOs and their

public and academic use.

Please send an abstract of 200-250 words, together with biographical background information of 50-100 words by 31 October 2015 to Professor Johannes-Dieter Steinert: J.D.Steinert@wlv.ac.uk. All proposals are subject to a review process. candidates Successful will informed at the end of 2015 and will be asked to send in their papers by the end of May 2016 for distribution among conference participants on a CD. Further information will be made available in due time.

Fee for speakers: EUR 160. The fee includes admission to all panels, lunches, coffees, teas, and evening events.

The aim of this special issue is to bring together articles from established and emergent academics and practitioners who have direct experience and empirical data on the lives of children in the Middle East and North African (MENA) regions, particularly since the Arab Spring uprisings. Our critical focus (Debbie Watson, Kristen Cheney and Heba Raouf Ezzat editors of this special issue) is on the role of children and

young people in influencing political and cultural change in the region and the impacts upon them of conflict and This ambition political change. emerged from a capacity building collaboration between the guest editors who were partners in a European Union (EU) Tempus-funded project: Diploma in Public Policy and Rights (2010-2013).universities in Egypt (Cairo University and Assiut University) and two in (Jordan University Hashemite University) with European partner universities (University of Bristol, England; Free University of Berlin, Germany; Maastricht University, Netherlands and the International Institute of Social University Studies of Erasmus Rotterdam, The Hague, Netherlands) as well as Research in Practice in England and United **Nations** Children's Fund (UNICEF) in Egypt and Jordan came together to develop a postgraduate diploma for advocates and children's rights practitioners in Egypt and Jordan to address the role of policymaking in facilitating the articles of the United **Nations** Convention on the Rights of the Child (UNCRC; UN, 1990) to be recognized in domestic law and in rights-based practice with children and young people.

# Towards Non-violent Schools: Prohibiting all corporal punishment, Global Report 2015

Towards Non-violent Schools: Prohibiting all corporal punishment, prepared and published by the Global Initiative to End all Corporal Punishment of Children, is a global report of the status of prohibition of corporal punishment in schools.

As of May 2015, corporal punishment is unlawful in all schools in 125 states, yet 73 states still fail to fully prohibit corporal punishment in learning institutions. The Global Initiative sees this as a violation of states' human rights obligation to prohibit all corporal punishment, wherever children and whoever the perpetrator.

The study continues with notable research and the necessary need of law reform; examples are given of both laws that prohibit and authorise corporal punishment in schools. State-by-state information is also provided on opportunities for prohibition as well as best-case scenarios where law reform has achieved change.

#### State of the World's Fathers 2015

Approximately 80 percent of men will become biological fathers at some point in their lives, and virtually all men have some connection to children – relatives, as teachers, as coaches, or simply as community members. Whether they are biological fathers, stepfathers, adoptive or foster fathers, or legal guardians; whether they are brothers, uncles, or grandfathers; whether they are in same-sex or opposite-sex relationships; and whether they live with their children or not, men's participation in the daily care of others has a lasting influence on the lives of children, women, and men, and an enduring impact on the world around them.

This first ever State of the World's Fathers report brings together key research international findings along with program and policy examples related to men's participation in caregiving; in sexual and reproductive health and rights; in maternal, newborn, and child health; in violence and violence prevention; and in child development.

#### **HOW TO JOIN THE ENMCR NETWORK?**

It is possible to join the European Network of Masters in Children's Rights as a member at any time. ENMCR was established in 2004 by five European Universities with the support of Save the Children Sweden (SCS). In the meantime 31 universities are members of ENMCR. ENMCR is collaborating with the Latin American Network of Masters in Children's Rights, which currently comprises nine universities in eight Latin American countries and is also supported by SCS. Furthermore, ENMCR is in contact with academic study programmes on children's rights in other parts of the world, e.g. in the MENA region.

#### Why is it worthwhile joining our network?

In becoming a member you will work with children's rights experts from all over Europe (and Latin America). We have been cooperating as a network for almost ten years and you will be able to build on the longstanding experience of our members. You will get an insight into children's rights from a variety of perspectives and disciplines. The member universities offer higher education in childhood studies and children's rights, at undergraduate, graduate and postgraduate levels. Some members offer full study programmes in children's rights, others offer modules, seminars or intensive courses. You will have access to knowledge in establishing study programmes, as well as to teaching materials developed in the network. We have implemented several European Union funded projects on children's rights themes and organize conferences, workshops and short intensive programmes in the same field. You will have access to all materials published in the frame of ENMCR, such as the monthly electronic newsletter Children's Rights news (CRnews), reports from projects, materials from conferences and workshops, etc.

To become a member of ENMCR, simply send us a letter of intent, in which you name what you believe you and your institution can contribute to and gain from our network. In addition, please include an outline of your child rights related programme and/or courses. It is important that you name a contact person at your institution for correspondence purposes. Our members contribute to ENMCR's work with an annual membership fee of 300€ which covers the daily expenses of the network.
